

# Terms and conditions: 80 Years in Ethiopia Anniversary Quiz Competition

OFFICIAL RULES TO ENTER OUR COMPETITIONS. NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. Eligibility: This Campaign is open only to those who sign up at the campaigns and who are 18 years or older as of the date of entry. The Campaign is only open to legal residents of Ethiopia, and is void where prohibited by law. Employees of British Council Ethiopia, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. 3. Campaign Period: Entries will be accepted online starting on November 05, 2022 18.30 (East African Time) and ending February 23, 2023 18.00 (East African Time). All online entries must be received by February 23, 2023 18.00 (East African Time).

4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided at the campaign URLs. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of British Council Ethiopia. Optional verbiage to include: You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of British Council Ethiopia.

Winner will be notified by email or phone within five (5) days following selection of Winner. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. British Council has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
